



Frequently Asked Questions

How do I apply for Pay as you Golf?

You can apply for Pay as you Golf by using our on-line application process at www.payasyougolf.com.au. If you elect to use the paperless option your application will be approved and processed immediately. Alternatively you can elect to print the Membership Registration Form, complete your payment details and forward the signed form to our office. Otherwise you can request an application form from your club's office.

How much are my instalments and when is the first instalment due?

The instalment amounts and dates can be confirmed during the on-line application process. They are also shown on the Membership Registration Form.

To ensure continuity of your playing rights please make sure that your nominated account has sufficient funds for each monthly payment.

What is the processing fee I will pay?

Our current processing charges are outlined at our web-site (www.payasyougolf.com.au). You can also calculate your monthly instalments at our web-site.

When will my golf club receive my fees?

Your club will be paid up-front and in full fourteen days after your initial instalment is paid.

Who will manage the instalment facility?

Victory Funding P/L will administer the collection of your instalments. Victory Funding P/L is a member of the Insurance Premium Finance Association of Australia.

I have just joined a new club. Can I use the Pay as you Golf facility for my joining fees?

The facility accommodates joining and annual membership fees. We can even accommodate annual house, bar and water levies if required.

My club does not offer the Pay as you Golf facility, can I use the facility?

The Pay as you Golf facility is only distributed through golf clubs. Please arrange for your club's Board or General Manager to contact us to enable the facility to be introduced at your club.

Pay as you Golf members enjoy:

- payment terms of up to ten months;
- an easy on-line pre-approved application process;
- the ability to set the monthly payment date;
- a choice of repayment options – monthly direct debit from a bank account or credit card (MasterCard and Visa Card); and
- fixed processing charges.

Importantly, even your golf club enjoys the benefits of Pay as you Golf. Your annual fees are paid to your club upfront and in full allowing the club to maximise their cashflows whilst ensuring your playing rights are maintained.

Golf club fees can place a strain on any household budget. The Pay as you Golf facility allows you to spread the cost of your annual golf fees across the year rather than paying them all at once.

Pay as you Golf allows you to concentrate on reducing your golf handicap not your bank balance.

The Pay as you Golf facility allows you to spread out the cost of your golf club's annual membership fees and joining fees (if applicable) plus some other annual fees that may be charged by the club (ie. water levies, house fees etc.).

To take advantage of the Pay as you Golf facility visit our web-site (www.payasyougolf.com.au) and select the 'Application Form' button.

By nominating your golf club, annual fees and preferred number of instalments our quick quote calculator will calculate your instalment amount.

You can then choose to proceed to our secure application facility.

If you do not wish to apply on-line you can obtain an application form from your club's office. Complete the details and forward the form to us. We will then send a Membership Registration Form to you for completion.

Alternatively you can call our office and our friendly team will be happy to assist you.

To ensure continuity of your playing rights please make sure that your nominated account has sufficient funds for the initial and subsequent instalments.

Please note that payment arrangements cannot extend beyond the relevant membership period.

All instalment options are consecutive monthly instalments (ie. not quarterly or half yearly).

Payment to the Club of your full annual fees will be made fourteen days after the initial instalment is paid.
